Roosevelt County Program Director Patrick Kircher introduced to the commission a new to Roosevelt County weed and the new SMCD Weed Management Board. The African Rue is toxic to livestock and humans, drought resistant weed that has a 20 to 25 foot tap root and 20 foot surface spread. Blading, disking and or otherwise cutting the plant will help it spread, along with seed pods being transported in tire treads. The only means to combat the weed is chemically. Board member Mike Cone stated the BLM has taken action this summer to combat the weed. Help from the Road Department and everyone else that has boots on the ground in locating this weed before it has a chance to establish is the request of the SMCD Weed Management Board. The next quarterly meeting will be December 8th at 1:30 p.m. at the Soil and Water Conservation Office.
