The detainees on work detail have been busy with maintenance, painting and work in the showers. There are 3 employees in the academy currently, which will bring the center to full staff.
- b. Road Road Superintendent Ricky Lovato reported his crews are cleaning cattle guards and blading where possible. Crews are also leaning the bar ditches on the blading routes. The rain while a blessing is also causing many problems with the roads. A priority list of repairs is updated daily with safety issues having priority.
- c. <u>Sheriff</u> Sheriff Malin Parker reported receiving a letter from the attorney general's office stating the sheriff will have to vacate the building. There was not a time frame for the vacancy. An invoice for \$3,200 for the waste water pond inspection was also included.
