<u>Grants and Special Projects</u> - Special Projects Coordinator Carol Acosta-Flores reported working on the CDBG ARISE project and has turned in the environmental to DFA which is closely supervising the project. Two interviews for the architect are complete, with one pending. <u>Road</u> - Road Superintendent Ricky Lovato reported attending a LGRF meeting in Albuquerque with another meeting in Roswell scheduled. LGRF School Bus projects are complete, LGRF COOP projects will be complete this week and LGRF CAPS projects will be complete by December 15<sup>th</sup>.
