## **Adjusting Precinct Boundaries**

**WHEREAS**, pursuant to Subsection A of NMSA 1978, Section 1-3-5 (2019), it is the duty of the Board of County Commissioners by resolution to create, divide, abolish, combine or adjust the boundaries of any precincts as necessary to meet the requirements of the Election Code as well as the legal and constitutional requirements for redistricting; *and* 

**WHEREAS**, pursuant to Subsection C of NMSA 1978, Section 1-3-12 (2019), in the year prior to a federal decennial census changes to precinct boundaries shall be upon the recommendation of the County Clerk; *and* 

**WHEREAS**, it has been determined by the County Clerk that precinct boundaries should be created, divided, abolished, combined or otherwise adjusted as provided in the map attached to this Resolution.

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of County Commissioners the precincts in the County shall conform to the adjustments and designations as shown on attached map and made part of this Resolution; *and* 

**BE IT FURTHER RESOLVED,** that pursuant to NMSA 1978, Section 1-3-8 (1975), upon adoption of this Resolution, the board of county commissioners shall send a certified copy of this Resolution to the secretary of state and to the county chair of each of the major political parties and shall publish once the resolution in a newspaper as provided in NMSA 1978, Section 1-1-14 (2011).
