Roads 10 and 12 in the Homeland Security projects are underway, the parking lot at the fairgrounds is finished, and preparations on the fairgrounds are also underway. Crews are performing routine maintenance and cleaning cattle guards and mowing has stopped due to the tractor breaking.

<u>Manager</u> - County Manager Amber Hamilton reported that the first round of the audit was finished last week with minor adjustments to be made. Monitoring the Fuel Distribution is also a priority. <u>Commissioners</u> - Commissioner Matthew Hunton expressed his gratitude for the work on the Right To Work Ordinance. Commissioner Gene Creighton reported oil & gas activity on the rise with 4 new wells in his district.
