Approval of Accounts Payable and Payroll:

Elected Officials/Department Heads Report:

Treasurer - Treasurer Lavle Sanchez reported that we have \$1.5 mil in the general fund as of the end of July. The 2014 delinquent tax sale will occur on September 19, 2018 at 9 a.m. in the Commission Room in the courthouse. There are 19 properties currently on the list, however, that list is subject to change until 5 p.m. on Sept. 18th. A new layout for the tax bills will be implemented on the tax bills that will go out on October 22, 2108.

<u>Detention</u> - RCDC Administrator Justin Porter reported 78 total detainees, 16 female, 62 male with 7 from other counties. Total number of August booking were 113 with 112 releases. Two officers are in the academy and can begin rotation next month, two more officers will start the academy next week, leaving 7 vacancies. The vacancies have been created out of life events, not a dissatisfaction with the position. NMAC audit an restrictive housing went well with a few suggestions in paperwork for improvement. Two supervisors have been sent to TREA investigative training.

Road - Road Superintendent Ricky Lovato reported the disaster fund work on S RR 10 is finished, S RR 12 to be completed next week, S RR U to be completed in 2 weeks, S RR W to be completed in 3 weeks, and S RR 18 and another part of W to be completed next month. Crews have completed 10.5 miles since June. Crews are also working on blading and routine maintenance. Shredding will begin today, as the shredder is now fixed, it will take 3 weeks to make a complete round of the county.

Manager - County Manager Amber Hamilton reported a conference call with a company in California regarding remote cameras that will allow the collection of evidence in illegal dumping in the areas that are frequented. The tax rates from the state have been received by the assessor and a special meeting will need to be scheduled. The second round CDBG meeting which was the presentation portion was a great success and awards will be announced on Wednesday. A letter from DFA stating the FY 18-19 final budget has been received and approved. Commissioners - Commissioner Dennis Lopez reported on the legislative priorities.

New Business:

a. Request for Approval of Asset Disposal / Removal from Inventory per Auditor Direction - County Manager Amber Hamilton stated there were 7 items that no longer needed to be monitored and can be removed from the asset list that are valued under \$5,000. Motion to approve the removal of the seven items was made by Commissioner Lewis Shane Lee with a second from Commissioner Dennis Lopez. <u>Commissioner Gene Creighton</u> then asked if there was anything that could be done about the appearance of the delinquent properties. Due to the two year redemption period, any improvements may be forfeit if the prior owner utilizes the redemption period. There is not at this time a county ordinance that deals with this issue.
