Elected Officials/Department Heads Report:

- a. Assessor Assessor George Beggs reported business as usual.
- b. <u>Clerk</u> Chief Deputy Clerk Stephanie Hicks reported business as usual.
- c. <u>Sheriff</u> Sheriff Malin Parker reported that the county won the lawsuit that was filed against him. He also reported about the many car burglaries mostly in the rural areas. He warned the people to be diligent in locking their cars and watching in their neighborhoods.
- d. <u>Detention</u> RCDC Administrator Justin Porter reported 65 in average custody a day. As of today they are housing 12 females and 53 males. On May 24, 17 they changed the classification of detainees. The staff did a great job moving inmates to their new pods and while moving the inmates they behaved as well as expected. In the Good Time Credit Policy the inmates have the opportunity to take classes to get their GED, also if they qualify they can join the RCDC workforce, working in the detention center or even outside on various county properties.
- e. Road Road Superintendent Ricky Lovato reported they have finished the LGRF COOP and School Bus projects and the Capital Outlay, his crew has also done 15 miles of chip seal and 4 miles of caliche. They are currently working on cattle guards and routine blade maintenance.
- f. Manager County Manager Amber Hamilton awarded Scott Chambers a Certificate of Appreciation for all the hard work he has put in with her at the detention center during the accreditation process. It was also reported that the county will receive the May and June payment for the Magistrate Court building, as their funding did come through during the emergency legislative session. A plan is being constructed to remedy the drainage situation at the fairgrounds.
