## **New Business:**

## Reconvene at Law Enforcement Complex: We reconvened at 1:21 p.m.

- a. Tour of the Remodeled Areas: Front entrance: bathrooms have been remodeled and hall repainted. We walked through the newly assigned offices of which they have been repainted and new carpet. Sheriff Parker stated the existing evidence vault room needs a secure ceiling.
- b. Review of the Requested Door Modification and Discussion: Sheriff Parker stated his office would like a door in the East/West corridor of the facility to add extra security to sheriff's portion of the building. Manager Hamilton is waiting to get clarification, in writing from the State Building Inspector, if an egress study is required or to see if the modification can be done without one. Consensus of the Sheriff and the RCDC Administrator: both entities need to be protected in their jobs within the shared building. That the building be secure and each have access to their assigned portions of the building. That all people in the facility have access to exits and restrooms, and that airflow not be compromised.
