Waters of the US is still in litigation with no ruling as of yet. The Lesser Prairie Chicken could be relisted on the endangered species list. The court is currently looking at that petition. Wolf territory is Eastern Arizona to the Texas border and south of I-40. Kevin Spears gave a <u>briefing of Roosevelt County Drug Court</u>. Mr. Spears stated they are running out of space where they are currently located in the courthouse. Temporarily they are being housed at the Chamber of Commerce. The request from the court is that the commission look into allocating the drug court new space within the courthouse. It was stated that drug court is a cost savings for the county verses confinement in the detention center. Repeat drug offences are down and the court program has a 94% success rate. So far there have been 8 graduates from the Portales drug court program, with 2 more pending graduates early this year.
