- b. <u>Clerk</u> County Clerk DeAun Searl reported being very busy with preparing for the school board election, today being the day to declare candidacy.
- c. <u>Sheriff</u> Sheriff Malin Parker reported assisting the Attorney General's office and the FBI in apprehending a child predator along with various other calls. A meeting with BAU pertaining to the repairs to the Armory building which houses the Sheriff's Office was attended and resulted in a contractor being sent out for an estimate.
- d. <u>Treasurer</u> Treasurer Layle Sanchez reported being 32% collected on the 2<sup>nd</sup> half taxes and 46% collected on delinquent taxes. Also a balance of \$2,398,396 in the general fund.
- e. <u>Detention</u> Roosevelt County Detention Center Administrator Larry Phillips reported 51 in custody, 45 males, 6 females; 4 out of county, 236 billable days as of November 1, 159 intakes with 176 releases and 2 release errors that were corrected prior to final release.
- f. <u>GIS/Rural Addressing/Floodplain Management</u> GIS Technician Johnny Montiel reported being very busy with software updates and site visits.

- i. Manager County Manager Amber Hamilton presented retirement plaques to Probate Judge Barbara George, Commissioner Richard Leal and Commissioner Jake Lopez. County Manager Amber Hamilton reported the swearing in ceremony will be January 3<sup>rd</sup> at 8:30 a.m. in the District Courtroom. The energy efficiency project is almost complete with Special Projects Coordinator Carol Acosta-Flores and Maintenance Director Gary Spinks spearheading. A new petition to list the Prairie Chicken as endangered has been filed along with other environmental issues that are being closely watched. A new procurement rule is being reviewed by NMAC that has the potential to be harmful to counties. A report on the FY 2016 Audit revealed 14 findings in 2015, 11 are resolved, 1 was new and 3 continue into 2016. High praise was given to the county by DFA for the corrective actions that were taken. Options for S RR Q ½ will be presented at the January 10, 2017 meeting.
- j. <u>Commissioners</u> Commissioner Lewis Shane Lee reported In Energy is looking at placing wind turbines in the south of the county and that 4-H presented the county with a Community Supporter Award.
