Informational Items:

Executive Business Director Stan Livengood introduced representatives from Natural Chem Group LLC; CEO/President Robert Salazar, Senior Vice President Frank Bustamonte, Executive Vice President Project Development Carter Conlin, National Manager Fred Chitty and Phelps Engineering Owner Lonnie Phelps. CEO Robert Salazar stated that Natural Chem has three components 1) production of bio diesel 2) glycerin which is a by-product of bio diesel 3) production of liquid natural gas. Lonnie Phelps stated the master plan for the industrial park was designed for the end user.

Chris Tokarski with Mental Health Resources stated that Turquoise Health & Wellness, the company that offered mental health services in New Mexico, was pulling out of the state. Services are being absorbed by MHR as of April 1, 2015.

David Sanders stated that an underground ridge that runs south of Arch separates salt water from the drinking water in Roosevelt County. The salt water is overflowing into clean water and that Natural Chem should clean and use the salt water instead of the clean water.
