The Roosevelt County Commission met in a Workshop, Tuesday, February 28, 2017, at 9:24 a.m. in the County Commission Room in the Roosevelt County Courthouse with those present being: Commissioner Paul Grider, Commissioner Gene Creighton, Commissioner Lewis Shane Lee, Commissioner Matthew Hunton, County Manager Amber Hamilton, County Clerk DeAun Searl, Sheriff Malin Parker, Lieutenant Javier Sanchez, Road Superintendent Ricky Lovato, Maintenance Director Gary Spinks, Assessor George Beggs, Chief Deputy Assessor Stevin Floyd, GIS Technician Johnny Montiel, Intern Cale Bloskas, and PNT Managing Editor Alisa Boswell. Call to Order - Chairman Paul Grider at 9:24 a.m.

**County Fleet Workshop:**

County Manager Amber Hamilton stated the purpose of this workshop was to get a solid perspective on the County fleet and the needs of the respective departments.

**Sheriff:**

Sheriff Malin Parker reported having 26 vehicles in his fleet, 5 of which to dispose. The need to replace 3 patrol vehicles and 1 transport vehicle will be reflected in the FY18 budget.

**Assessor:**

Assessor George Beggs reported having 2 vehicles in his fleet, 1 of which has an oil leak. The need to replace both vehicles, possibly from the 1% fund, will be reflected in the FY18 budget.

**Road:**

Road Superintendent Ricky Lovato reported having 50 vehicles/equipment in his fleet, 9 of which need to be replaced and 1 of which needs to be repaired. Replacing 1 tractor and 2 pick-ups will be reflected in the FY18 budget.

**Administration:**

County Manager Amber Hamilton reported having 2 vehicles in her fleet. There is no need for a budget request.

**Maintenance:**

Maintenance Director Gary Spinks reported having 2 vehicles in his fleet, 1 having an oil leak. Replacing 1 vehicle will be reflected in the FY18 budget.

**Planning:**


GIS Technician Johnny Montiel reported having 1 vehicle. There is no need for a budget request.

County Manager Amber Hamilton reported 3 vehicles in this fleet. There is no need for a budget request.


