Informational Items: Roosevelt Soil & Water Conservation District Annual Commission Update: Mr. Cone reported they have sold or given away 85,000 shade balls, with very good reported results. Each shade ball cost \$.53. They are still working with the weed management group. He also reported they are watching HB-460 Appropriation to the NM Dept. of Agriculture for a Weather Modification Program in the amount of 1.2 mill.

# **Elected Officials/Department Heads Report**:

<u>Sheriff</u>: Sheriff Parker is watching several pieces of gun legislation and asked the commissioners to write letters to the governor opposing these bills. He is concerned these will pass.

<u>Detention</u>: RCDC Administrator Porter reported 69 detainees (53 males and 16 females) with 10 being from out of county, 98 bookings and 100 releases for the month of January, of those 3 are in restrictive housing (2 males, 1 female). USAF owes \$13,050 for housing 4 detainees. They are still working on collecting this. Also Colfax was billed for \$15,795 all for January. Two officers have completed academy training and 1 officer started full time today. Weather permitting the detainees will start the outside work projects. The project of refurbishing the dayrooms is going well. One dayroom has been repainted, new led lighting and is in the process of getting new locks on the cell doors. The next dayroom will be started soon. RCDC will be updating and implementing some policies in the near future.

<u>Finance</u>: Finance Specialist Rivera reported the 2<sup>nd</sup> quarter report has been submitted and all funds are reporting well. As of December 31<sup>st</sup> we are at 68.38% in revenues and 57.53% in expenditures.

**Road**: Road Superintendent Lovato reported they are finished with the homeland security and disaster funds. From June - current they have completed 21 miles. He added, 61 culverts have been installed for drainage. Mr. Lovato thanked Mrs. Jones & Mrs. Flores for helping with the daily log sheets and Mrs. Rivera for her help with the finance portion of this project. He also commended his crew for a job well done. 2019 LGRF project has just started and routine maintenance is always happening.

<u>Manager</u>: Manager Hamilton stated she is watching several bills making their way through the legislative process. Clovis has extended an invitation to talk about mental health. Phase 1 of the phone system upgrade will be this Thursday and Friday, with phase 2 starting on February 25<sup>th</sup>. The state auditor and NMAC recognized Roosevelt County with the Audit and Accountability Award FY-2017.
