RESOLUTION 2015-59
PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED
BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be \$327,785.00 to be funded in proportional share by the parties hereto as follows:

a. New Mexico Department of Transportation's share shall be 75% or \$245,839.00

and

b. **Roosevelt County's** proportional matching share shall be 25% or \$81,946.00.

TOTAL PROJECT COST IS **\$327,785.00**

Roosevelt County shall pay all costs, which exceed the total amount of **\$327,785.00**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on **December 31, 2015** and the Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it resolved by the Roosevelt County to enter into Cooperative Agreement Project Number CAP-2-15(458), Control Number L200247 with the New Mexico Department of Transportation for LGRF Project for year **2014 – 2015 for caliche rehabilitation of one mile on SRR 8 ½ between NM 206 and SRR Q; one mile on SRR U between SRR 3 and NM 236; two miles of SRR X between NM 267 and NM 236; two miles on SRR 4 between NM 236 and SRR X; two miles on SRR 8 between SRR E and SRR G; two miles on SRR E between NM 88 and SRR 8; one half mile on SRR Q between 9 and SRR 9 1/2** within the control of the Roosevelt County in Roosevelt County, New Mexico.







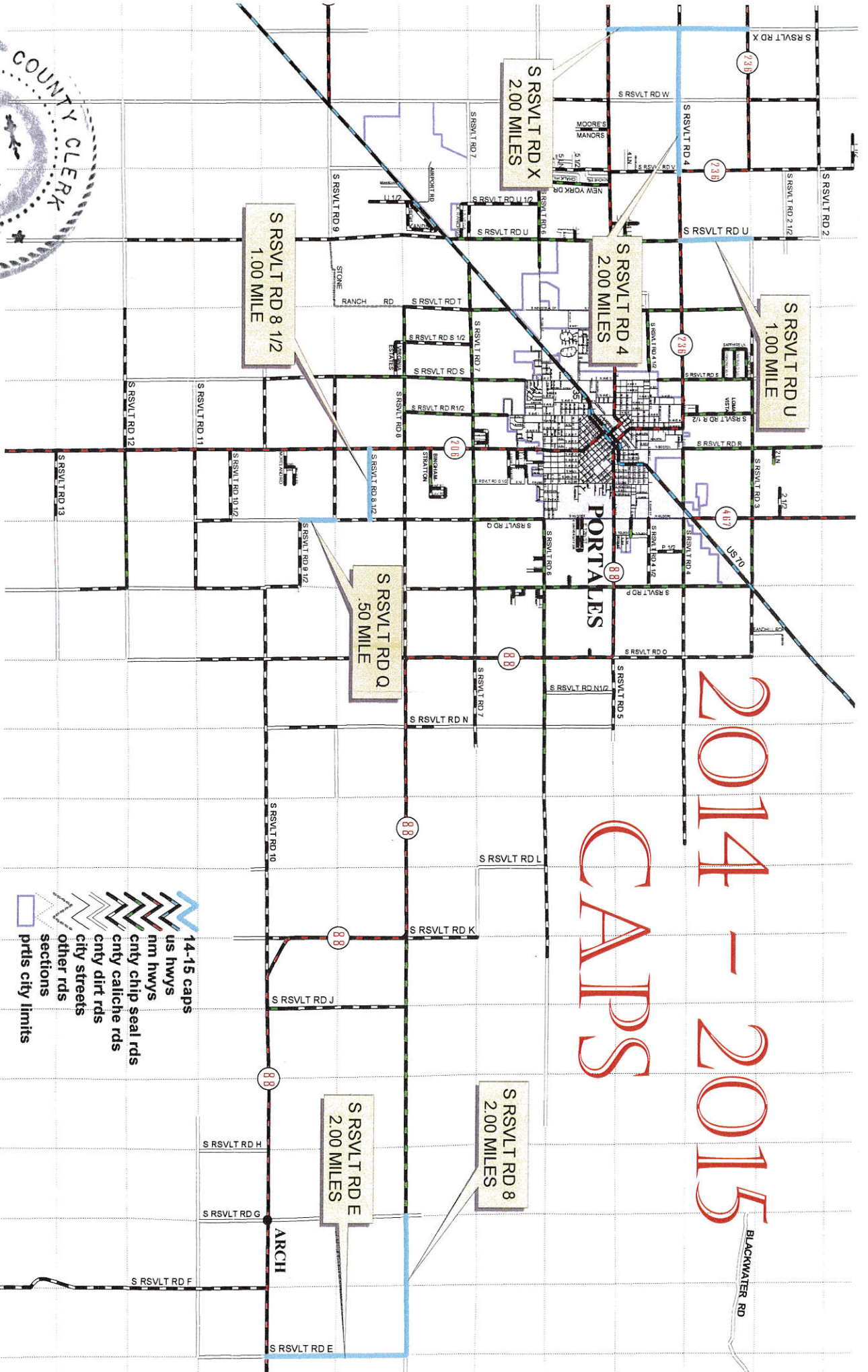
