



**RESOLUTION NUMBER: 2017-37**

**Resolution for Participation in Local Government Road Fund Program Administered by  
New Mexico Department of Transportation**

WHEREAS, the Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$137,333.00** to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or **\$103,000.00**

and

- b. Improvements, drainage improvements, misc. on approximately four miles of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or **\$34,333.00**

**TOTAL PROJECT COST IS \$137,333.00**

Roosevelt County shall pay all costs, which exceed the total amount of **\$137,333.00**.

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

The project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2018 and Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

**NOW THEREFORE BE IT RESOLVED**, by Roosevelt County, to enter into Cooperative Agreement Project Number SB-7741(930)18, Control Number L200392 with the New Mexico Department of Transportation for LGRF Project for year 2017 – 2018 to Termini Caliche SRR Q one mile between SRR 7 and SRR 8; Chip seal SRR S one mile between SRR 3 and NM 236; Chip seal SRR 6 one mile between SRR U and SRR V; Calichi SRR 35 two and one half miles between SRR Z and SRR AD. Scope of work: design, construct and reconstructing, blading and shaping; caliche, chip seal rehabilitation improvements, drainage improvements, misc. on approximately five and a half miles of various County roads.




NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF ROOSEVELT COUNTY, that the completed SB application is approved.



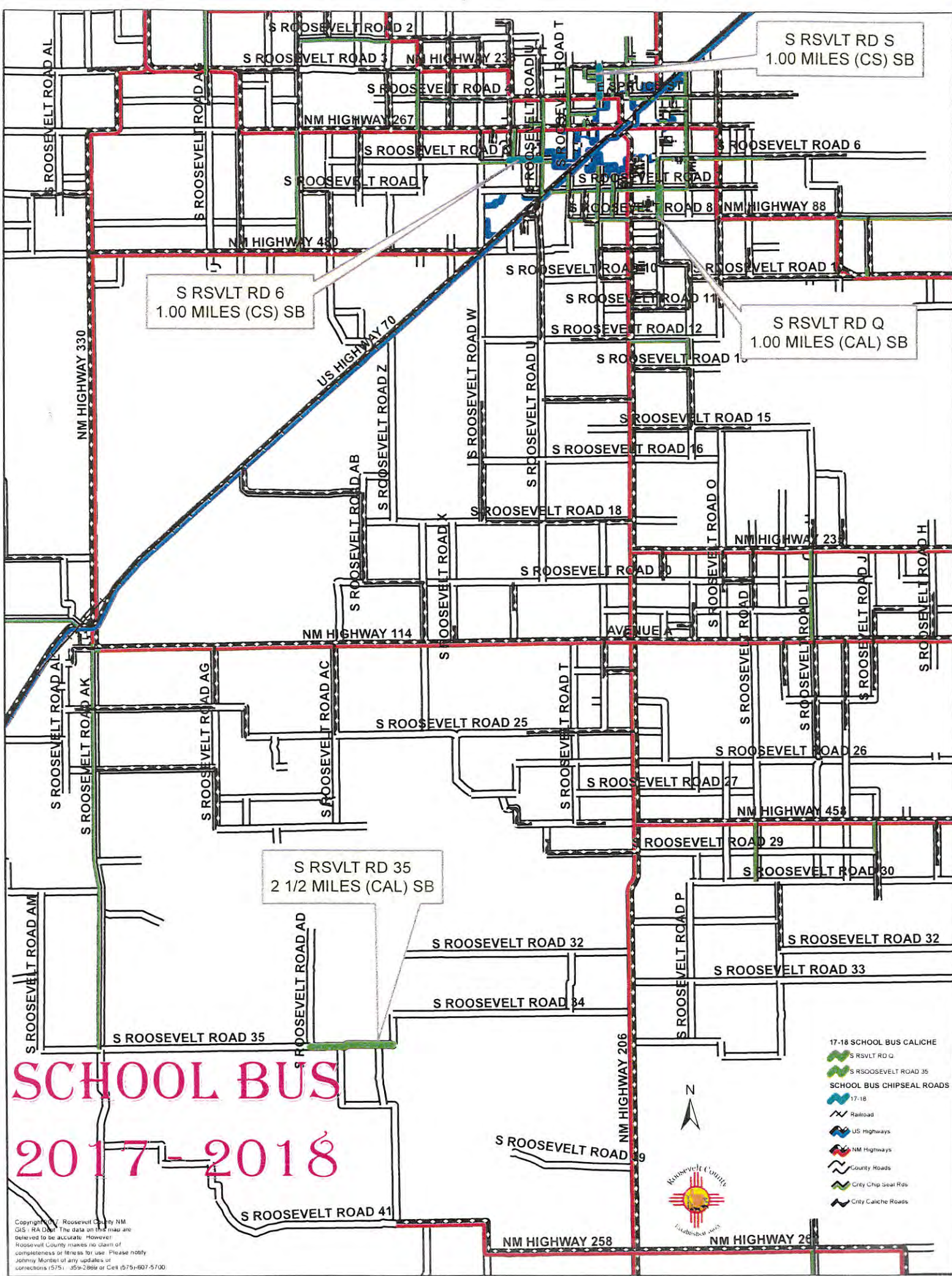
