**Resolution for Participation in Local Government Road Fund Program Administered by
New Mexico Department of Transportation**

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$562,678.66** to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or **\$422,009.00**

and

- b. improvements, drainage improvements, misc. on approximately 12.33 miles of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or **\$140,669.66**

TOTAL PROJECT COST IS \$562,678.66

Roosevelt County shall pay all costs, which exceed the total amount of **\$562,678.66**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2019 and the Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.



NOW THEREFORE BE IT RESOLVED, by Roosevelt County, to enter into Cooperative Agreement Project Number CAP-2-19(457), Control Number L200436 with the New Mexico Department of Transportation for LGRF Project for year 2018 – 2019 to Termini One mile cal/cs SRR 4 from SRR O to SRR P; One mile cal/cs SRR 7 from NM 88 to SRR P; .50 mile cal SRR V Place from SRR 5 ½ to SRR 6; .25 mile cal from SRR 5 ½ V East; .25 cal SRR 5 Lane from SRR V East; .25 mile cs Broadmoor Acres, South of NM 267; .25 mile cs Redwine Ball; .25 mile cs Redwine Quincy; .07 mile cs Redwine Cherry; .07 mile cs Redwine; .07 mile cs Redwine Orange; .50 mile cal/cs East 12 St. from Kilgore to Natchez; .50 mile cal/cs East University from Kilgore to Natchez; .06 mile cal/cs Modesto from E. University to E 12th St.; .06 mile cal/cs Natchez from E. University to 12th St; .25 mile cal/cs South Ave. B from 18th St. to 21st St.; .50 mile cal/cs 21st St. from SRR Q ½ to NM 206; 1 mile cal/cs SRR 3 from Highway 70 to SRR O; .50 mile cal Sandhill Road; .50 mile cal SRR 4 ½ from SRR T Place to SRR T; .50 mile cal SRR T Place from SRR 4 ½ to NM 267; 2 miles cal/cs SRR V from NM 236 to SRR 6; 1 mile cs/cal SRR 3 from SRR S to SRR T; .50 mile cal SRR P ½ from SRR 4 to SRR 4 ½; .50 mile cal SRR 4 ½ from SRR P ½ to Kilgore;

Scope of work: to design construct, reconstruct blading and shaping, caliche, chip seal, fog seal rehabilitation improvements, drainage improvements, misc. on approximately 12.33 miles of various County Maintained Roads.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF ROOSEVELT COUNTY, that the completed CAP application is approved.
