



RESOLUTION NUMBER: 2018-26

**Resolution for Participation in Local Government Road Fund Program Administered by
New Mexico Department of Transportation**

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$500,000.00** to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or **\$375,000.00**

and

- b. improvements, drainage improvements, misc. on approximately 23.25 miles of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or **\$125,000.00**

TOTAL PROJECT COST IS \$500,000.00

Roosevelt County shall pay all costs, which exceed the total amount of **\$500,000.00**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2019 and the Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

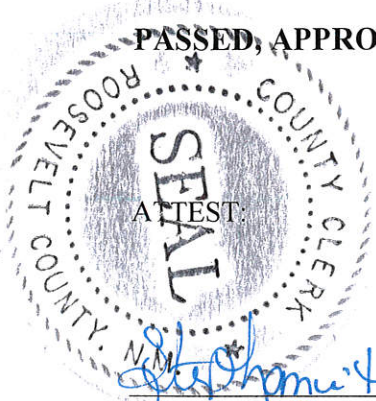
NOW THEREFORE BE IT RESOLVED, by Roosevelt County, to enter into Cooperative Agreement Project Number COOP SP-2-19(957), Control Number L200404 with the New Mexico Department of Transportation for LGRF Project for year 2018 – 2019 to Termini; 3 miles cal/cs SRR 8 from NM 88 to NM 206; 2 miles cs SRR 6 from SRR U to SRR W; 0.25 mile cs East Amazon; 0.75 mile fs SRR R ½ from Yucca Dr. to SRR 7; 2 miles fs SRR 12 from NM 206 to SRR P; 0.75 mile cs SRR T from Highway 70 to SRR 7; 2.75 miles cs SRR 7 from Highway 70 to NM 206; 5 miles fs SRR 21 from Highway 70 to SRR AP; 2 miles fs SRR AP from SRR 21 to SRR 19; 3 miles cs SRR 2 from NM 236 to SRR AD; 0.25 mile cs Springwood addition; 1 mile cal SRR 15 from NM 206 to SRR S; 0.5 mile cal Virginia Estates;



Scope of work: to design construct, reconstruct blading and shaping, caliche, chip seal, fog seal rehabilitation improvements, drainage improvements, misc. on approximately 23.25 miles of various County Maintained Roads.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF ROOSEVELT COUNTY, that the completed COOP application is approved.

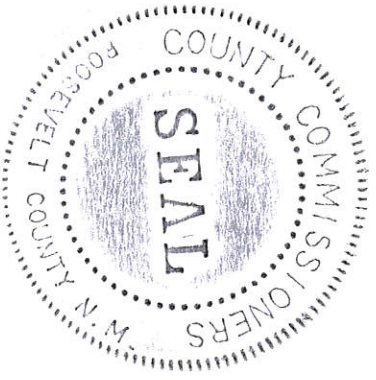
