County Manager Amber Hamilton recommended updating the ordinances and forming a committee to plan and monitor the plan for land use in Roosevelt County. Charles Bennett stated land use is a critical issue and the ordinance should be a living document to keep in step with current issues such as the prairie chicken and playa lakes. County Attorney Rick Queener stated the ordinance needed to include wind energy and solar farms and be forward-thinking. Sharon Davis stated that the ordinance needed to be in place in a timely manner to protect the wind interest presently in the county. No action needed, no action taken.
