## **Elected Officials/Department Heads Report:**

- a. <u>Detention</u> RCDC Administrator Justin Porter reported 73 in custody, 18 female, 55 male, none in special management. There were 88 intakes and 105 releases with no errors, with an average population of 79. The Detention Center passed an inspection performed by the Fire Marshal. One new hire beginning training today and three more beginning on Monday, which will bring the center up to fully staffed. The center was without water service for three days and with the help of the road department the facility continued to run. Also several detainees were able to help out at the fairgrounds during the water outage. One citizen's complaint concerning a phone not working properly.
- b. <u>Risk Management</u> Human Resource Administrator Debra Olds reported on behalf of the Safety Committee. The six month review was received from James Chavez from NMAC. The review stated that in the last three years Roosevelt County has had an average per year of 9 work comp claims, 8 multi-line claims, 2.3 auto claims and 6.3 law enforcement claims. Since instituting the RAP program the claims have been thus: 4 work comp, 4 multi-line, 0 auto and 1 law enforcement. This is on target to meet our goal of decrease by 10%.
- Road Road Superintendent Ricky Lovato reported all blades running especially on school bus routes. One blade not running but will be repaired today.
- d. <u>Manager</u> County Manager Amber Hamilton reported state officials will be traveling Roosevelt County roads to view the damage in the disaster declaration turned in to FEMA. Milnesand received a rating of an ISO of 5, Chief John Mohon started 17 years ago with a rating of 9. Arch is still waiting on a rating. DFA has approved the final FY18 budget.
- e. <u>Commissioners</u> None.

- a. <u>Board of Finance Meeting</u> Motion to go into Finance Meeting was made by Commissioner Lewis Shane Lee with a second from Commissioner Paul Grider. Treasurer Layle Sanchez presented the board with an investment portfolio summary which highlighted the fees that Roosevelt County is paying on the investments. These fees are greater than the return on the investments. A recommendation from Treasurer Layle Sanchez was to transfer management of the portfolio to a company that will not charge fees. - b. Request for Approval for Treasurer to Transfer \$320,000 to Moreton Capital Markets, LLC Treasurer Layle Sanchez requested to transfer funds for investment. The reserve funds will remain above the 2 million requirement. Motion to approve was made by Commissioner Matthew Hunton with a second from Commissioner Gene Creighton. - c. Consideration of Road Closure of S RR Q ½ from 6 ½ and SRR 7; Phase I of Q ½ Road Closure Project Road Superintendent Ricky Lovato requested approval to begin the process of ordering equipment for Phase 1 of closing S RR Q 1/2. Phase I includes break away signage, rumble strips, solar beacon lights and a gate. Phase II pertains to ordering the railing. Phase III would complete the closure by installing the railing. Motion to close S RR Q ½ at the City Water turn-out to S RR 6 ½ as Phase I was made by Commissioner Lewis Shane Lee with a second from Commissioner Gene Creighton. - d. Request of Road Closure in District V: SRR AO for 2.28 miles between SRR 7 and SRR 9 and SRR 8 for 2.01 miles between S RR AM and S RR AO; and Appointment of Road Viewer Committee Road Superintendent Ricky Lovato requested the appointment of Dave Nash, Clovis Grey and Lindell Thompson as road views. Motion to approve the appointment was made by Commissioner Gene Creighton with a second from Commissioner Paul Grider. - e. <u>Discussion of Drainage Issues on S RR 8 between S RR Q and S RR P</u> Road Superintendent Ricky Lovato stated control of the drainage of brown water runoff into the playa has been requested. GIF Technician Johnny Montiel stated that he spoke with Brian Shaw with the EPA and a permit was issued to the City of Portales in 2015. Commission requested formal communication begin with City of Portales pertaining to the control of water flow into the playa.
- f. Consideration of Road Department Restructuring Road Superintendent Ricky Lovato stated restructuring the blade routes from 5 to 7 routes would alleviate the burden of miles per blade and allow more blading to be performed per year. The request for one full-time and one temporary employee (max of 9 months) with no negative impact on the budget, the funds would come from the cash reserves. Motion to approve new organizational chart for the road department was made by Commissioner Paul Grider with a second from Commissioner Lewis Shane Lee.
