Public Requests:

County Manager Amber Hamilton recognized JP Stone representatives David Stone, Linda Davis and Richard Bradfute attending the meeting in response to the payroll problem on December 12, 2014. Additional training will be scheduled to safeguard future transactions.

Elected Officials/Department Heads Report:

- a. RCCDC Director Stan Livengood reported the purchase of 722 S RR U owned by Nancy Williams located on the corner of RR U and HWY 70 for the purpose of a new entrance to the Industrial Park. Natural Chem is working toward developing in Roosevelt County and is working with CoBank looking into taxable bonds.
- b. <u>Assessor</u> Chief Deputy Stevin Floyd reported his office is wrapping up end of year business. Commissioner Bill Cathey congratulated Assessor Elect George Beggs on his election.
- c. <u>Healthcare Assistance and Capital Projects</u> Administrative Assistant Mandi Park reported on the CDBG project concerning Arise and where that project stands. Mrs. Park reported that fewer indigent healthcare claims are being received.
- d. <u>Treasurer</u> Treasurer Nancy Belcher reported first half collections. The total billed amount is \$7,500,000 and her office has collected \$4,500,000. The remainder is due May 10, 2015. The funds for the Magistrate court has earned just over \$400 in interest. The LPL investments have a gain of \$10,000. Commissioner Bill Cathey presented a gift to Nancy Belcher's for her retirement.
- e. Sheriff Not Present.
- f. Detention Not Present.
- g. <u>Clerk</u> County Clerk DeAun Searl reported the automatic recount was complete. Today is filing day for the school board elections. Commissioner Kendell Buzard asked the outcome of the recount. Searl replied Dunn to be the clear winner.
- h. Road Road Superintendent Ricky Lovato reported that five years ago, 2 miles of S RR 18 between S RR AN and S RR AP were reconstructed and that during construction the crew got too close to a fence line and now the fence line is laying down. A meeting with the County Manager and the landowner

will be scheduled to address this issue. In October of this year, Sovereign Eagle took a drilling rig over county cattle guards on S RR 10 causing a shift of the guard. Sovereign Eagle filled the bunk boards to fill the gaps. Mr. Crenshaw is now aware that there is a procedure and will follow that procedure in the future. Caliche crew #2 is working subgrade on S RR P which will take a few weeks. Sweatt Construction has all three cattle guards in and the two miles are complete. Mr. Lovato also reported many problems with the tumbleweeds.

- i. Manager County Manager Amber Hamilton reported a successful meeting at BIPO, Better Informed Public Officials. New handbooks for the two commissioners that were unable to attend will be available to them. The Roosevelt Wind project transaction will be closing on December 19, 2014 with Bonnie Paisley as legal counsel. December 30, 2014 is scheduled to be the swear-in date for the newly elected officials. DFA accepted the budget audit. Mr. Fouts corrected a few technicalities and there will be one finding in it that was submitted late. A special commission meeting needs to be scheduled in early January to address a budget shortfall. The venue for the special meeting scheduled for the 22nd of January has been relocated to Portales. Commissioner Kendell Buzard requested Mr. Kopelman and Mrs. Phillips be invited to that meeting.
- j. <u>Commissioners</u> Commissioner Bill Cathey stated this meeting would be his last and expressed his pleasure in serving Roosevelt County for the past eight years.
