- a. <u>USDA Wildlife Specialist</u> USDA Wildlife Specialist Cliff Ruppert reported on his quarterly report for October through December. Total acreage worked is 80,925 acres, total properties worked is 18, total hours worked 565, total loss reported at \$6,352, total loss verified \$33,166, total number of samples taken 42. New samples include bird sampling. Current work includes 2 ranches east of Lingo, 1 south of Dora, 1 north of Floyd, 1 in Arch, 1 south of Portales and 1 in Elida.
- Assessor Assessor George Beggs reported his office is doing year end clean up and preparing for start of 2015.
- c. <u>Healthcare Assistance and Capital Projects</u> Administrative Assistant Mandi Park reported working with DFA (Department of Finance Administration) on CDBG (Community Development Block Grant) to get the RFP published for the architect. The comprehensive plan project is on hold awaiting an answer from NMFA. The annual report for healthcare will be prepared and ready next month.
- d. <u>RCCDC</u> RCCDC Director Stan Livengood reported the continued effort to bring Natural Chem into the Industrial Park. Natural Chem representatives will be in Portales on February 16, 2015. Natural Chem is looking for a \$1.5 to 2 million construction loan.
- e. <u>Treasurer</u> Treasurer Layle Sanchez reported that her office is working on December statements.
- f. Sheriff Sheriff Malin Parker presented the commission with a call log of the last 2 months to emphasize the amount of calls his deputies field in lieu of taking meeting time.
- g. <u>Detention</u> RCDC Administrator David Casanova reported 63 inmates, 1 from Quay County and 4 unfilled positions.
- h. <u>Clerk</u> County Clerk DeAun Searl reported voter registration books will be closing at 5 p.m. today and absentee voting will begin in the Clerk's office on Friday, January 9th for the school board elections.
- i. <u>Road</u> Road Superintendent Ricky Lovato reported being very busy clearing snow. The two crews working on LGRF projects were pulled from those projects to clear snow. The school bus routes were the first to be cleared and are complete.
- j. Manager County Manager Amber Hamilton reported a special meeting has been scheduled for January 15, 2015 to address budget issues. A minimum of 5% deficiency in revenue has been identified. Department heads and elected officials have been asked to have suggestions for budget reductions. The county administration offices will be open during the noon hour starting January 12 to provide better customer service. A representative from DFA will be onsite to help the county resolve the budget issues in late January. The surety bond from EDF has been sent and meetings with Alan Cowen are being scheduled. Williamson reported a 90% completion of the basement along with a request to close the parking lot for crane work during the last week of January.
