<u>Public Requests</u>: Dairyman and Curry County Resident Art Schaap wants to hold CAFB accountable for the contaminated water around the baseand asked the commission to contact the Governor in reference to this issue. He brought this concern to the commission since the county has land connected to the AFB, as well on his behalf. This contamination has affected his dairy and home supply of water. Mr. Schaap stated he had to lay off several employees due to this issue, which effects the local economy.

Elected Officials/Department Heads Report:

Detention: RCDC Administrator Porter reported 80 detainees (60 males and 20 females) with 10 being from out of county, 89 bookings and 80 releases for the month of December, of those 8 are in restrictive housing (5 males and 3 females) and \$30,300.00 total billed for the month. Two officers have completed academy training, 3 are currently in the academy and 1 starts on the 14th. One detainee is being housed at the Department of Corrections. Maintenance is continuing with the light replacement project, dayroom maintenance, repairs and cleanup. Update on the Narcan/Naloxone program: The policy for education and distribution has been in place since March 2018 and distribution began on April 14, 2018. Since then over 1,000 detainees have been trained and provided information upon intake and release from RCDC. They have issued 49 Narcan/Naloxone kits into the community to individuals being released from custody. Each kit contains two doses. The staff had to use one of these kits on a detainee due to an overdose that happened just prior to arriving at RCDC, they were able to see the benefit of their training & use of the kit.

Special Projects Coordinator Acosta-Flores reported there were 14 claims in the amount of \$11,321.33. Her recommendation is to approve 8 of the claims in the amount of \$3,897.43.

<u>HR: Employee Recognition</u>: Human Resources Administrator Olds and Chairman Lee presented certificates to several employees for their years of service.

Road: Road Superintendent Lovato reported his crew is busy on S RR 18, and installing culverts, trimming trees and wrestling tumbleweeds in the county. With the homeland security disaster monies the road department has finished 28.5 miles of roads.

Manager: Manager Hamilton stated we would need a special commission meeting on Friday to approve today's minutes. There are changes coming to the county insurance and she has a meeting next week to learn more about this. Legislative Conference will be next week. Manager Hamilton asked Road Superintendent Lovato to recertify the 2019 roads, to make sure the list is accurately assessed. The offices are doing well in maintaining their budgets and we have collected 68.10% of our estimated revenues.

<u>Commissioners</u>: Commissioner Lopez stated he will be attending the NMAC Board meeting next week.

Commissioner Hunton: RCDC Administrator Porter and staff are doing a fantastic job taking care of business. Commissioner Lopez: what a great turnaround the facility has done compared to his previous terms. Commissioner Grider: the facility was very clean and he would be proud to show it to anyone. Commissioner Dixon: the facility was very clean and orderly. Manager Hamilton stated the facility looks and runs the same day in and day out, whether there is a scheduled visit or a drop in visitor.
