ROOSEVELT COUNTY, NEW MEXICO ORDINANCE NO. 2018-02 AMENDING ORDINANCE NUMBER 2017-02

AMENDING ROOSEVELT COUNTY ORDINANCE NO. 2017-02 WHICH AUTHORIZED THE IMPOSITION OF THE COUNTY'S LOCAL HOSPITAL GROSS RECEIPTS TAX WITHIN THE COUNTY UNTIL JULY 1, 2037; EXTENDING THE IMPOSITION OF THE COUNTY'S LOCAL HOSPITAL GROSS RECEIPTS TAX UNTIL JULY 1, 2047 SO AS TO PERMIT THE ROOSEVELT COUNTY SPECIAL HOSPITAL DISTRICT TO (I) REFUND AND REDEEM CERTAIN OUTSTANDING LOANS DATED DECEMBER 21, 1999, (II) TO OBTAIN ADDITIONAL FINANCING TO FUND PROPOSED HOSPITAL EXPANSION PROJECTS, AND (III) TO CLARIFY THE DEDICATION LANGUAGE.

BE IT ORDAINED BY THE GOVERNING BODY OF ROOSEVELT COUNTY:

- Section 1. Imposition of Tax. There will be imposed on any person engaging in business in this county for the privilege of engaging in business in this county an excise tax equal to one-half of one percent (½ %) of the gross receipts reported or required to be reported by the person pursuant to the New Mexico Gross Receipts and Compensating Tax Act as it now exists or as it may be amended. The tax imposed under this ordinance is pursuant to the Local Hospital Gross Receipts Tax Act as it now exists or as it may be amended as shall be known as the "local hospital gross receipts tax."
- **Section 2. General Provisions.** This ordinance hereby adopts by reference all definitions, exemptions and deductions contained in the Gross Receipts and Compensating Tax Act as it now exists or as it may be amended. This Ordinance amends and restates in full Roosevelt County Ordinance No 2017-02.
- **Section 3. Specific Exemptions.** No local hospital gross receipts tax shall be imposed on the gross receipts arising from:
- A. transporting persons or property for hire by railroad, motor vehicle, air transportation or any other means from one point within the county to another point outside the county; or
 - B. direct broadcast satellite services.
- Section 4. Dedication. Revenue from the local hospital gross receipts tax is dedicated for:
- 1. acquisition of land or buildings for and the design, construction, renovation, equipping or furnishing of a hospital facility or health clinic owned by the county or a hospital or health clinic with which the county has entered into a health care facilities contract, lease or management contract.



Section 5. Effective Date. The effective date of the local hospital gross receipts tax shall be July 1, 2017.

Section 6. Delayed Repeal. Ordinance Number 2018-02 (if it becomes law) and the local hospital gross receipts tax is repealed effective July 1, 2047.
