a. Williamson Restoration representatives John Espindola provided a presentation of the retro-fit for the HVAC project for the courthouse. Completion date is set for early August. A Variant Refrigerant Volume or VRV System will replace the current system. Refrigerant piping will replace the water piping. This system will allow for more ventilation and better control of the temperature.

- a. RCCDC RCCDC Director Stan Livengood reported he is working with state land management to utilize the state land in Roosevelt County. He is working with Jeff Kepert on the wind project. He will also meet with Causey Village on Tuesday the 8<sup>th</sup>.
- b. <u>USDA Wildlife Specialist</u> Cliff Ruppert reported on the fiscal year 13-14, finding total damages at \$24,346.00 in Roosevelt County. The quarterly report showed \$6944.00. Currently he is working 2 properties concerning predators.

- e. <u>Treasurer</u> Treasurer Nancy Belcher reported her office had a good response to the delinquent letters. The NM Tax & Revenue Dept sold all 12 of the properties on the auction block. The collection rate is at 96%.
