### <u>Resolutions – Ordinances – Proclamations:</u>

- a. Approve Ordinance 2014-08 Authorizing the Execution and Delivery of a Loan Agreement Between
   Roosevelt County and the New Mexico Finance Authority for the Purpose of Financing the Repair,
   Replacement, Construction, Upgrading and Acquisition of the HVAC System in the County Courthouse
   – David Buchholtz stated the loan amount was \$2,875,00 and would be a senior loan. Motion to
   approve was made by Commissioner Richard Leal, with a second from Commissioner Kendell Buzard.
   3 yes votes by roll call.
- b. Approve Resolution 2014-37 Declaring July 14 through July 18, 2014 as "New Mexico Hunger Week" County Manager Charlene Webb stated the North Central New Mexico Economic Development District drafted this resolution to bring to light the issue of child hunger. Motion to approve was made by Commissioner Kendell Buzard, with a second from Commissioner Scott Burton. 3 yes votes by roll call
- c. Approve Resolution 2014-38 Approving Final Budget Adjustments County Manager Charlene Webb stated approval was needed to finalize the fiscal year. First consideration was \$134,346.25 for the new magistrate facility which will be recouped through the lease agreement with Administrative Office of the Courts AOC. The second consideration is allocate funds for the emergency HVAC renovations and mold remediation for the courthouse. Incurred expenses total \$565,549.07 which will be reimbursed through the ordinance 2014-08. The third consideration is an upgrade to the security for the Detention Center totaling \$237,394.97, which was offset by \$786,237 for housing inmates from other counties. Motion to approve was made by Commissioner Scott Burton, with a second from Commissioner Richard Leal. 3 yes votes by roll call.

## **New Business:**

a. Accept Petition to Stop the Proposal for the Legal Sale on Marijuana in Roosevelt County – Arkie Kiehne stated Santa Fe would legalize the sale of recreational marijuana in the state of New Mexico and he felt Roosevelt County needs to take a proactive stance against the proposal. He presented a petition with 830 signatures. Under Sheriff Malin Parker stated that marijuana is the Mexican drug cartel's number one source of funding, with the legalization of marijuana, the cartel would have to import harsher drugs to make up for the profit loss. These drugs would cause more violent crimes

and be a detriment to the county. Wade Fraze stated that the ingestible marijuana is very dangerous to the children, teens and adults, and enticing to the kids. Legalizing it sends a message to our kids that it is ok or normal and acceptable. Leon Nall stated the negative effects on lives and families in the community would not be worth the tax advantage. Motion to accept the petition and direct County Attorney Rick Queener to formulate a resolution was made by Commissioner Richard Leal, with a second from Commissioner Scott Burton. 3 yes votes.

- b. <u>National Flood Plain Insurance Program Presentation and Approval to begin the Application Process to Enroll in the Program</u> Bill Borthwick gave a presentation. Motion to table was made by Commissioner Kendell Buzard, with a second from Commissioner Scott Burton. 3 yes votes.
- c. <u>Retroactive Approval for Application for CDWI Funds</u> County Manager Charlene Webb stated this was a retroactive approval for a grant for \$6,332 for the DWI program. Motion to approve was made by Commissioner Scott Burton, with a second from Commissioner Richard Leal. 3 yes votes.
- d. <u>Approve CivicHR Application Tracking System Proposal</u> HR Manager Jena Wilbanks stated this program will track the applicant pool and accept applications online. Funding for this program is not included in the budget and would cost \$4,000, however funds could be reallocated. Motion to approve was made by Commissioner Scott Burton, with a second from Commissioner Richard Leal. 3 yes votes.

- b. <u>Approve Agreement for Inmate Confinement Between the County of Roosevelt and the County of Guadalupe</u> Roosevelt Detention Administrator David Casanova stated Guadalupe County had an agreement with a private prison and this agreement would be for over max capacity and would be mostly female inmates. Motion to approve was made by Commissioner Scott Burton, with a second from Richard Leal. 3 yes votes.
- c. <u>Approve Agreement for Inmate Confinement Between the County of Roosevelt and the County of Taos</u> Roosevelt Detention Administrator David Casanova stated Taos County had requested housing for an inmate. Motion to approve was made by Commissioner Richard Leal, with a second from Scott Burton. 3 yes votes.
- d. Approve Agreement for Inmate Confinement Between the County of Roosevelt and the County of Rio Arriba – Roosevelt Detention Administrator David Casanova stated Rio Arriba had requested housing for inmates. Motion to approve was made by Commissioner Scott Burton, with a second from Kendell Buzard. 3 yes votes.
- e. <u>Approve Agreement for Inmate Confinement Between the County of Roosevelt and the County of Chaves</u> Roosevelt Detention Administrator David Casanova stated this agreement was for juveniles. Motion to approve was made by Commissioner Richard Leal, with a second from Kendell Buzard. 3 yes votes.
- f. Approve Samba Safety Master Service Agreement Between the County of Roosevelt and Samba Safety

   HR Manager Jena Wilbanks stated this program is a driver risk management system that
  automatically monitors our drivers on a monthly basis. Motion to approve was made by
  Commissioner Richard Leal, with a second from Scott Burton. 3 yes votes.
- g. <u>Approve Memorandum of Understanding for New Mexico Driver Information Between the County of Roosevelt and Samba Safety</u> Motion to approve was made by Commissioner Scott Burton, with a second from Richard Leal. 3 yes votes.
