RESOLUTION NO. 2013-24

A RESOLUTION REGARDING A JOINT LAND USE STUDY PERTAINING TO ROOSEVELT AND CURRY COUNTIES FOR THE PURPOSE OF COORDINATING EFFORTS BETWEEN MUNICIPALITIES, LAND OWNERS, CANNON AIR FORCE BASE AND MELROSE AIR FORCE RANGE

WHEREAS a Joint Land Use Study (Cannon Air Force Base and Melrose Air Force Range), dated March, 2011 (hereinafter "JLUS 2011") was accepted by the Roosevelt County Commission at the March 15, 2011 regular meeting.

WHEREAS the Commission accepted the JLUS 2011 only so the study costs could be paid; and

WHEREAS the Roosevelt County Commission does not agree with all of the findings, statements, assumptions and presumptions contained within the JLUS 2011.

WHEREAS the Roosevelt County Commission did not intend in March 2011 to adopt any of the findings, statements, assumptions, and presumptions in the JLUS and was assured at the March 28, 2011 meeting that by the JLUS Committee that the County was not obligated to adopt any of the findings, statements, assumptions, and presumptions contained within the JLUS 2011.

WHEREAS the Roosevelt County Commission desires to make a clear statement that the JLUS 2011 is not precedent from which all future relations with the CAFB and MAFR must proceed;

THEREFORE, BE IT RESOLVED that the JLUS 2011 is considered by the Roosevelt County Commission as nothing more than a statement of the members of the JLUS 2011 committee.

BE IT FURTHER RESOLVED that the Roosevelt County does not agree with all of the findings, statements, assumptions and presumptions contained within the JLUS 2011.

BE IT FURTHER RESOLVED that the JLUS 2011 is not binding in any way on the Roosevelt County Commission, Roosevelt County, or any resident thereof.

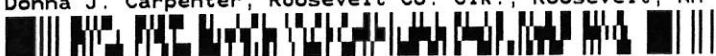
