Elected Officials/Department Heads Report:

- a. <u>RCCDC</u> RCCDC Director Stan Livengood reported that he is working on the website and that he is also researching incentives for new business for the county. He also stated that 23% of the county has a Bachelor's Degree or better meaning that the workforce in Roosevelt County matches the national average and that should attract technical business to this area. Research is also being done on the railroad spurs in this county.
