# **Elected Officials/Department Heads Report:**

Detention: RCDC Administrator Porter recognized Officers Aaron Flores and Geneva Gonzales on their 1 year anniversary with RCDC. Porter reported 73 detainees (57 males & 16 females) with 3 being from out of county, 107 bookings and 122 releases for the month of August. Total billing for the month of August was \$19,275.00. Facility update: routine maintenance, replacing dayroom and cell windows, painting and removing graffiti in dayrooms and cells. The outside projects have slowed down due to weather and staffing issues. Road Superintendent Ricky Lovato and the road department have been working on the access road to the visitation area. The fixes and upgrades are much better and are holding up through the recent rain. We have 3 officers going through Academy Training and one more starting next week. Administrator Porter and a few other detention administrators have been working with NMC on some new policies that will be presented to the detention affiliate in October. These policies are being written and modified to meet the latest legislative requirements. Porter said the new policies are helping very well with the evaluation process when taking in out of county detainees.

<u>Clerk</u>: Clerk Hicks reported that NMC and Otero County filed a lawsuit challenging a portion of HB 407 and won in the NM Supreme Court. The SOS was ordered to: Revert any district updates and term extensions that occurred as a result of the one-time realignment. This is in the matter of the commission districts and the extension of terms. Hicks also stated that filing day for the November 5<sup>th</sup> Local Election was successful. She reported that Floyd will have one vacancy, as will the Border Soil & Water Conservation District. Due to the unfunded mandates that have been established in HB 407 we are not sure what the budgetary requirements are going to look like. We will have a better view of this issue after November.

**Commissioners**: Commissioner Dixon stated her appreciation on how well the fairgrounds look and how well the 2019 fair went. Exceptional work from Maintenance Director Gary Spinks and Anthony Ortega. Commissioner Lopez will be attending the Gathering of Counties at the NM State Fair next week.
