

There were some equipment errors but, once those were taken care of, the election went well. Commissioner Lopez asked when the county questions, regarding alcohol sales in the unincorporated areas that passed, would take effect. County Manager Hamilton replied, she would get the certificates to the New Mexico Regulation Licensing Department then contact the county attorney to go from there.
