

You shall not violate any local, state or federal criminal law of these United States.

You shall not, possess, consume, purchase or distribute any alcoholic beverages. You shall not associate with anyone possessing or consuming alcoholic beverages. You shall not at any time enter a bar or lounge where alcoholic beverages are served or sold for consumption on the premises (this excludes convenient stores or grocery stores).

You shall not possess, consume, purchase, or distribute narcotic drugs, marijuana or synthetic marijuana in any form.

You shall not own, possess, or sell any firearms or other deadly weapons

You shall report in person to the Roosevelt County Compliance Officer as often as he/she requests. Any payments, certificates, or other documentation requested by your officer is also due at those appointments. Failure to report at your designated appointment will result in a violation and a warrant. You shall obey all instructions of your Compliance Officer.

You shall pay the compliance cost of **\$50 per month** with a **MONEY ORDER ONLY** made payable to Roosevelt County, on or before your report date each month.

You shall pay by **MONEY ORDER ONLY** made payable to Roosevelt County, drug testing fees of \$25.00 every 182 days. You shall submit yourself for random drug screening at the request of your Compliance Officer. If more testing is required this will be at **your** cost.

You shall report immediately any arrest or charge to your Compliance Officer, even traffic tickets.

You shall not associate with any person identified by your Compliance Officer as a detriment to your Compliance, including, but not limited to, anyone on probation or parole, or anyone having a criminal record.

You shall not endanger in any way the person, property, or morals of others.

You shall obtain permission from your Compliance Officer **BEFORE**: (A) Leaving the county in which you are being supervised; or (B) Changing residence. (You may travel freely within Roosevelt, and/or Curry Counties. If you wish to travel outside Roosevelt, or Curry Counties, you must obtain **PRIOR** approval from your Compliance Officer in the form of a written travel permit.)

You shall permit your Compliance Officer to visit you at your home, or place of employment at any time, and you will permit a warrant-less search and or confiscation, by your Compliance Officer, of your person, automobile, residence, property and/or living quarters to ensure compliance of your Compliance conditions.

You shall make every effort to obtain and hold a legitimate job, and shall cooperate with your Compliance Officer in any effort that is made to obtain employment for you. If you lose or change your job for any reason, you shall report this to your Compliance Officer within 48 hours.

You may be ordered to Special Conditions in addition to the above Standard Conditions
