



RESOLUTION NUMBER: 2021-29

Participation in Local Government Road Fund Program Administered by New Mexico Department of Transportation

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$146,666.67** to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or **\$110,000.00**

and

- b. improvements, drainage improvements, misc. on approximately sixteen miles of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or **\$36,666.67**

TOTAL PROJECT COST IS \$146,666.67

Roosevelt County shall pay all costs, which exceed the total amount of **\$146,666.67**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2022 and the Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW THEREFORE BE IT RESOLVED, by Roosevelt County, to enter into Cooperative Agreement COOP Control Number L200525 with the New Mexico Department of Transportation for LGRF Project for year 2021 – 2022 to Termini: 1 mile caliche SRR AG from NM 267 to SRR 4; 1 mile micro seal SRR 8 from NM 206 to SRR S; 0.5 mile cal/cs SRR U ½ from Hwy 70 ½ mile north; 0.75 mile cal/cs SRR 4 ½ city limits to SRR T; 2.5 miles caliche SRR U from SRR 9 to SRR 11 ½ ; 1 mile SRR 7 from SRR AC to SRR AD; 1 mile cal/cs/ms SRR Y from NM 267 to SRR 6; 2 miles caliche SRR F from SRR 14 to SRR 16; 1 mile caliche SRR X from SRR 18 to SRR 19;

Scope of work: to design construct, reconstruct blading and shaping, caliche, chip seal overlay micro seal rehabilitation improvements, drainage improvements, misc. administrative management and engineer certifications on approximately eleven miles of various County roads.
