

RESOLUTION NO. 2022-18

Sponsorship for a Transportation Project Fund and Project Match Commitment for Funding Application of Seventy-Two and Three Quarter Miles of Various Roosevelt County Rural Roadways

WHEREAS, the County of Roosevelt, New Mexico, is a local Government corporation, and has the legal authority to apply for, receive, and administer state funds; and

WHEREAS, the County of Roosevelt is submitting an application for Fiscal Year 2023 Transportation Project Fund in the amount of \$2,878,154

WHEREAS, the County of Roosevelt does not intend to request a waiver for the matching fund requirement if the option is available, and;

WHEREAS, the County of Roosevelt will commit to the 5% match or \$143,907.70 for this project if the match waiver is not available and;

WHEREAS, the County of Roosevelt agrees to pay any costs that exceed the project amount if the application is selected for funding, and;

WHEREAS, the Project is a road construction rehabilitation and safety upgrades to 72.75 miles of various County roads and, is an eligible project under the New Mexico Transportation Project Fund requirements, and;

WHEREAS, these rural roadways that connect to State highways are considered major local service roads by the County of Roosevelt, and;

WHEREAS, the New Mexico Department of Transportation requests, as part of the application procedure, passage and submittal of a local government resolution of support for the project.

NOW THEREFORE, BE IT RESOLVED THAT, the County of Roosevelt supports the preparation and submittal of an application in accordance with the procedures established by the New Mexico Department of Transportation and the state of New Mexico, with Amber Hamilton, County Manager to submit the application on behalf of the County of Roosevelt.
