



## PROCLAMATION

### National Police Week: May 11-17, 2022 and National Peace Officers Memorial Day: May 15, 2021

**WHEREAS**, in 1962, President Kennedy proclaimed May 15<sup>th</sup> as National Peace Officers Memorial Day and the calendar week in which May 15 falls, as National Police Week; and

**WHEREAS**, National Police Week is a collaborative effort of many organizations dedicated to honoring America's law enforcement community and give special recognition to those law enforcement officers who have lost their lives in the line of duty for the safety and protection of others; and

**WHEREAS**, law enforcement officers strive to maintain a safe environment for all, often while facing significant challenges and dangers, and our community recognizes the important work and sacrifices officers make each day to protect the citizens of Roosevelt County; and

**WHEREAS**, the Roosevelt County Sheriff's Office is comprised of nine Deputies, two Sergeants, a Lieutenant and Sheriff, three Transport Officers, and one Executive Secretary; and

**WHEREAS**, there are more than 800,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Roosevelt County Sheriff's Office; and

**WHEREAS**, it is important for all citizens to know and understand the duties, responsibilities, hazards, and sacrifices of their law enforcement agency, and that members of our Roosevelt County Sheriff's Office recognize their duty to serve the people by safeguarding life and property, by protecting against violence and disorder, and by protecting the innocent against deception and the weak against oppression; and

**WHEREAS**, nearly 60,000 assaults against law enforcement officers are reported each year, resulting in approximately 18,000 injuries a year; and

**WHEREAS**, since the first recorded death in 1786, more than 23,000 law enforcement officers in the United States have made the ultimate sacrifice and lost their lives in the line of duty; and

**WHEREAS**, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, D.C.; and

**WHEREAS**, 619 new names of fallen heroes are being added to the National Law Enforcement Officers Memorial this spring, including 472 officers killed in 2021 and 147 officers killed in previous years; and

**WHEREAS**, the service and sacrifice of all officers killed in the line of duty will be honored during the National Law Enforcement Officers Memorial Fund's 34th Annual Candlelight Vigil on the evening of May 13, 2022; and

**WHEREAS**, May 15, 2022 is designated as National Peace Officers Memorial Day and all U.S. flags should be flown at half-staff, in honor of all fallen officers and their families; and

**NOW THEREFORE, BE IT RESOLVED** that the Board of Roosevelt County Commissioners, will observe May 11-17, 2022 as:

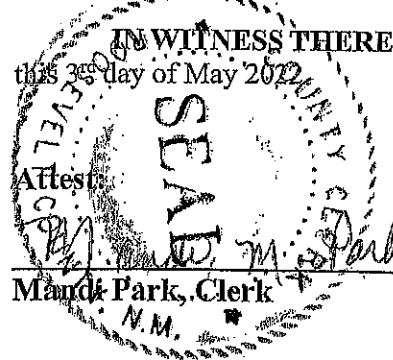

**"National Peace Officers Memorial Day"**

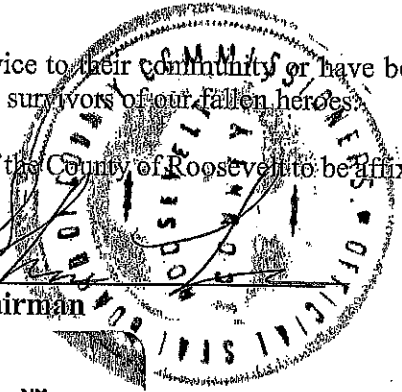
