



RESOLUTION NUMBER: 2023-08

Listing Priorities of State Roads Needing Repair within Roosevelt County

WHEREAS, Roosevelt County has numerous roads which are in significant need of repair; and

WHEREAS, the District Engineer for the New Mexico Department of Transportation requested a revised listing of priorities for the State Highway Department to be able to assist in the repair of some roads, but needs the County to make a list of its priorities of the roads which need the most immediate attention.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Roosevelt hereby lists and identifies those roads within Roosevelt County, New Mexico which are in urgent need of repair in order of priority:

NM 88 from City of Portales to Texas Border

-roadway in need of repair and widened from Portales to Arch, lacks adequate shoulders for safety

NM 236 from City of Portales to NM 267

-roadway in need of repair and widened, lacks adequate shoulders for safety

NM 267 from City of Portales to the merge with NM 330

-roadway in need of repair and widened, lacks adequate shoulders for safety

NM 114 from Elida to Texas border

-lacks adequate shoulders for safety; roadway in need of repair and widened from Dora to Texas border

NM 202 from US Highway 70 to Texas border

-roadway in need of repair and widened, lacks adequate shoulders for safety

NM 330 from Town of Elida to the merge with NM 267

-roadway in need of repair and widened, lacks adequate shoulders for safety, areas need drainage improvements

NM 60/84 from DeBaca County to mile marker 354;

-overall design of the roadway needs to be assessed as there have been multiple vehicular accidents, numerous fatalities and the design has created a very serious safety concern

NM 235 from NM 206 to Texas Border

-roadway in need of repair, lacks adequate shoulders for safety

NM 480 from US 70 to NM 267

-roadway in need of repair and widened, lacks adequate shoulders for safety, areas need drainage improvements

NM 458 from NM 206 to NM 114

-roadway in need of repair, lacks adequate shoulders for safety

NM206 from City of Portales to Lea County

-roadway needs overlay

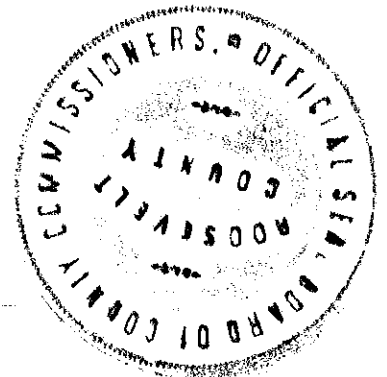
