



**RESOLUTION NUMBER: 2020-17**

**Resolution for Participation in Local Government Road Fund Program Administered by  
New Mexico Department of Transportation**

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$266,667.00** to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or **\$200,000.00**

and

- b. improvements, drainage improvements, misc. on approximately sixteen miles of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or **\$66,667.00**

**TOTAL PROJECT COST IS \$266,667.00**

Roosevelt County shall pay all costs, which exceed the total amount of **\$266,667.00**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2021 and the Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

**NOW THEREFORE BE IT RESOLVED**, by Roosevelt County, to enter into Cooperative Agreement COOP Control Number L200488 with the New Mexico Department of Transportation for LGRF Project for year 2020 – 2021 to Termini: 2 miles cal SRR P from SRR 13 to SRR 15; 2 miles cs overlay SRR AG from NM 236 NM 267; 1.5 miles cal SRR AB from SRR 16 1/2 to SRR 18; .25 mile cs overlay East Amazon; .5 mile cal SRR 4 1/2 from Kilgore to SRR P 1/2; .5 mile cal SRR P 1/2 from SRR 4 to SRR 4 1/2; 3 miles pmm SRR 4 from Kilgore to SRR N; 3 miles pmm Baseline from NM 467 to SRR N; 1 mile pmm SRR 3 from Hwy 70 to SRR O; 1 mile c/cs SRR W from NM 267 to SRR 6; 1 mile cal Baseline from NM 267 to SRR AJ; 2
