**Resolution for Participation in Local Government Road Fund Program Administered by
New Mexico Department of Transportation**

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$339,031.00** to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or **\$254,273.00**

and

- b. improvements, drainage improvements, misc. on approximately nineteen miles of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or **\$84,758.00**

TOTAL PROJECT COST IS \$339,031.00

Roosevelt County shall pay all costs, which exceed the total amount of **\$339,031.00**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2024 and the Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW THEREFORE BE IT RESOLVED, by Roosevelt County, to enter into Cooperative Agreement CAP Control No. L200611 with the New Mexico Department of Transportation LGRF Project for year 2023 – 2024 to **Termini**: 05 mile C/CS SRR U 1/2 from Hwy 70 1/2 mile South; .75 mile C/CS SRR 4 1/2 from City Limits to SRR T; 1 mile Vans Subdivision; 2 miles C SRR G from SRR 8 to NM 88; .5 mile C SRR 2 1/2 from NM 467 West 1/2 mile; 1 mile C SRR AU from SRR 28 North 1 mile; 5 miles C NRR AP from NRR 16 to NM 60/84; 1 mile C SRR S from SRR 11 TO SRR 12; 1 mile C SRR 11 from SRR Q to SRR P; 1 mile C SRR 34 from SRR Y to SRR Z; 1 mile C SRR Z from SRR 34 to SRR 35; 1 mile MS SRR 19 from SRR AP to SRR AV; 3 miles C SRR 33 from NM 206 to SRR 0;



Scope of work: to design construct, reconstruct blading and shaping, caliche, chip seal, and micro seal rehabilitation improvements, drainage improvements, misc. administrative management and engineering certifications on approximately nineteen miles of various County Maintained Roads.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF ROOSEVELT COUNTY, that the completed CAP application is approved.
