

RESOLUTION NUMBER: 2023-37

Participation in Capital Outlay Program Administered by New Mexico Department of Transportation

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be \$854,960.00 to be funded by the parties hereto as follows:

a. New Mexico Department of Transportation's share shall be 100% or \$400,000.00

and

b. Roosevelt County's proportional matching share shall be 0%

TOTAL PROJECT COST IS \$854,960.00

Roosevelt County shall pay all costs, which exceed the total amount of \$400,000.00

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing. The agreement terminates on June 30, 2027 (Laws of 2023) and Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it resolved by Roosevelt County to enter into Cooperative Agreement Control Number C2233344 with the New Mexico Department of Transportation for Capital Outlay (Laws of 2023) Rehabilitation Chip Seal Caliche, design, blading, culverts, drainage and misc. Construction, reconstruction and administration management to: 2 miles caliche SRR O from NM 88 to SRR 10; 1 mile caliche SRR 7 from SRR L to SRR K; 1 mile caliche SRR AB from NM 236 to SRR 2; 5 miles caliche NRR AP from NRR 15 to NRR 17; 1 mile caliche SRR 1 from SRR Y to SRR Z; 0.6 mile cal/cs SRR U ½ to US 70 south; 2 miles caliche SRR 10 from SRR U to SRR S; 1 mile caliche SRR 10 from SRR AE to SRR AF; .75 mile cs/ms Vans; 2 miles caliche SRR G from SRR 8 to NM 88; .75 mile cal/cs SRR 4 ½ City limits to SRR T; 2 miles caliche SRR 20 from NM 206 to SRR P; 2 miles caliche SRR 3 from SRR AD to SRR AB; 1 mile cal/cs SRR T from NM 236 to NM 267; 100 ft. concrete SRR P Intersection of P and NM 88; within the controls of Roosevelt County in Portales, New Mexico.
