## 2025 LIVESTOCK REPORTING

Dear Livestock Owner,

It is the responsibility of the taxpayer to report all livestock located in Roosevelt County for more than 21 days after January 1<sup>st</sup>, to the Roosevelt County Assessor's Office for property taxation purposes. You are required to complete the attached livestock schedule and return it to our office no later than <u>February 28th 2025</u> (7-36-21 NMSA), so that we can update our livestock records for tax purposes. Even if you no longer own livestock in Roosevelt County, please complete the attached form so that we may update our records. It is the taxpayers responsibility to let us know when the cattle leave the county. If you fail to return this form your previous numbers will roll forward with penalty and interest. Please let us know when your cattle are no longer in the county to alleviate issues in the future.

If you do not state how many months the livestock will be located in the county or how long you will own them, we will tax them for the full year! If you have livestock located in more than one school district, you will need to fill out an additional form for each location.
