



RESOLUTION NUMBER: 2025-10

Establishing Double-Time Pay Rates for Overtime Worked for Safer New Mexico Traffic Grants and or Any Other Grant Fund Allowing Double-Time Pay

WHEREAS, the Roosevelt County Sheriff's Office (RCSO) Deputies are encouraged to participate in Traffic Grant overtime. Traffic Grant overtime is received by agreements with Safer New Mexico, division of the New Mexico Department of Transportation. Overtime worked on the grant is subject to change upon the agreement with Safer New Mexico.

WHEREAS, to incentivize program funding are used to encourage the public to voluntarily comply with the motor vehicle/traffic laws of the State of New Mexico and Roosevelt County.

WHEREAS, pay will be based on a minimum of three citations per hours issued, citations must be either a written warning, court appearance or penalty assessment.

WHEREAS, during DWI saturation patrol, one DWI arrest will satisfy the requirements of citations per four-hour block.

WHEREAS, DWI saturation patrol requires at least one DWI arrest for every twenty-four hours worked, or for Operation Buckle Down, at least one of the citations per hour must be for a seatbelt or occupant restraint violation,

WHEREAS, the Deputy working the grant overtime will select the correct pay code of 435-OT for Grant Overtime or Double Grant Overtime for as long as grant funding is available, the Grant forms must be turned in to the Supervisor no later than the following and must contain the correct rate of pay worked.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of County Commissioners of Roosevelt County that following double-time pay rates for overtime worked for Safer New Mexico and/or any other grant funded approved work so long as grant funding is available, shall be established in Roosevelt County, New Mexico.
