



RESOLUTION NUMBER: 2025-23

Participation in Local Government Road Fund Program Administered by New Mexico Department of Transportation

WHEREAS, **Roosevelt County** and the New Mexico Department of Transportation (NMDOT) enter into a cooperative grant agreement under the Local Government Road Fund (LGRF) Program for a local road project.

WHEREAS, the total cost of the project will be **\$336,651** to be funded in proportional share by the parties hereto as follows:

a. New Mexico Department of Transportation's share shall be 75% or **\$252,488**

and

Rehab/improvements of various County roads, within the control of the Roosevelt County in Portales, New Mexico. Roosevelt County's proportional matching share shall be 25% or \$84,163

TOTAL PROJECT COST IS \$336,651

WHEREAS, Roosevelt County shall pay all costs, which exceed the total amount of \$336,651.

NOW THEREFORE, BE IT RESOLVED, in official session that Roosevelt County determines, resolves, and orders as follows:

- a. The project for this Cooperative agreement is adopted and has a priority standing.
- b. The agreement terminates on December 31, 2026 and Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.
- c. The agent of Roosevelt County, <u>Interim County Manager or County Manager</u>, shall have signature authority to bind Roosevelt County to the terms and conditions of the Cooperative Agreement, and shall have authority to request in writing and secure extension to the Cooperative Agreement on behalf of Roosevelt County in the manner set forth by the Cooperative Agreement.


NOW THEREFORE, BE IT RESOLVED, by Roosevelt County, to enter into Cooperative Agreement for County Arterial Program (CAP) Project Control Number L200683 with the New Mexico Department of Transportation for LGRF Program for fiscal year 2026 for reconstruction, blading and shaping of caliche, maintenance and rehabilitation/improvements on various county roads to include SRR B, SRR X, SRR 3 and SRR 30. **NOW, THEREFORE BE IT FURTHER RESOLVED,** by the governing body of Roosevelt County, that the completed Cooperative CAP application submitted to NMDOT was approved and is signified by the agreement attached hereto and incorporated herein, is approved.
