NEW MEXICO CAPITAL OUTLAY GRANT AGREEMENT
DEPARTMENT OF TRANSPORTATION
CAPITAL APPROPRIATION PROJECT

WHEREAS, Roosevelt County and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be \$652,000.00 to be funded by the parties hereto as follows:

a. New Mexico Department of Transportation's share shall be \$525,000.00

and

b. Roosevelt County's share shall be \$127,000.00

TOTAL PROJECT COST IS \$652,000.00. Roosevelt County shall pay all costs, which exceed the total amount of **\$525,000.00**

Now therefore, be it resolved in official session that Roosevelt County determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on June 30, 2029 (Laws of 2025) and Roosevelt County incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it further resolved by Roosevelt County to enter into Cooperative Agreement Control Number C2253285 with the New Mexico Department of Transportation for Capital Outlay (Laws of 2025) to rehabilitate, construct and reconstruct road improvements, including chip seal, caliche, and micro seal on county-maintained roads in Roosevelt County: 2 miles caliche/chip seal/micro seal SRR 8 from NM 88 to SRR I; 2 miles caliche SRR F from NM 88 to SRR 12; 2 miles caliche SRR X from SRR 20 to 1/5 miles South; 3 miles caliche SRR O from NM 235 to SRR 16; 1 mile caliche SRR 34 from SRR X to SRR Y; 2 miles caliche SRR 14 from SRR AP to SRR AR; 1 mile caliche SRR 1 from SRR Y to SRR Z; 1 mile caliche, chipseal, and micro seal SRR T from NM 236 to NM 267 within the controls of Roosevelt County in Portales, New Mexico.

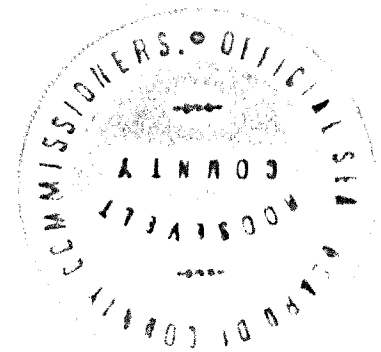

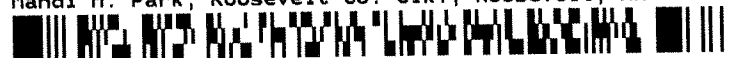
